4 MS. McDANIEL: Madame Chairman, Commissioners. My  
5 name is Lola McDaniel. I am employed at Hollywood Park Race  
6 Track. I've been at Hollywood Park for 18½ years. I am with  
7 H.E.R.E. Local Eleven --

9 MS. McDANIEL: And I am also a relative  
10 caregiver/foster parent. One of the reasons why I could become a  
11 foster parent is because I'm gainfully employed. The state of  
12 California does not provide full benefits for relative  
13 caregivers, only for foster parents, so with me having a job I  
14 can take the children, I have full medical coverage with Local  
15 II, collective bargaining. Because I can take care of the  
16 children on my own with a little help, of course.

17 I'm very glad to be here today because with being a  
18 relative caregiver I'm very, I've had two children. One from  
19 child abuse, one from substance abuse, and now I'm here today  
20 before you because of another abuse. And I have to worry about  
21 whether I'll still have my job.

22 As a citizen I'm very concerned about that. I would  
23 hope that Congress, this commission, along with everybody in this  
24 room that we're all here to solve whatever problems we have. I'm  
25 sitting at table right now, if the leg broke everyone in this  
26 room would say, let's fix it. Why can't we all collectively fix  
27 it, do what we do at H.E.R.E. Local Eleven especially well I  
28 might add, collectively bargain.
