Declaration of True Facts

We are James Alan Meisinger and Janet Lee Meisinger. To understand our standing in law, see Attachment #1 **Amendment 7 Notice and Demand, Declaration of Natural Rights** which has been published and cured in the **Colorado Statesman** without a single challenge to the facts and law therein.

In our 45 years of marriage, our family has been irreparably damaged by criminal acts of IRS officials, not once – but twice! The first time, was when the *federal reserve banks unlawfully and without warning* raised their *interest rates* overnight to over *21% usury interest* causing us to loose our lumber yard and hardware store. Right after that, we were attacked by IRS officials who fraudulently claimed we owed thousands of dollars we did not owe and forcing us to *borrow money from the federal reserve banks*. The federal reserve banks certainly profited by their un-American and unlawful acts! **The federal reserve caused millions of small businesses to fail, costing tens of millions of people their creative way of earning a living and destroying much of middle income America. Do you suppose that was the intent?**

The second time, in 1997, IRS officials acting out of 3 'districts' fraudulently liened and levied us, we were more aware and knowledgeable. We had an **honest Enrolled IRS Agent** write 11 and 13 page letters for us, testifying that what all those IRS officials and their accommodators had done were criminal acts. After 2 years of **IRS officials refusing to look and the facts and law** and causing Jim to be without work, we were finally able to force those criminal IRS officials to remove the lien and levy, but, **once again, they had already irreparably damaged our family.**

We attempted to get restoration through the courts in a co-plaintiff case with many other people

living in Colorado who had been severely financially damaged. However, those running the federal courts accommodated the IRS officials' criminal acts by dismissing our case out, rather than hold IRS officials accountable and see to it that our family was restored. One of the many co-plaintiffs was Ken Winchell, who had served this country as a pilot in 3 wars. IRS officials stole over \$5 million worth of property from him and the last we heard he was destitute and very ill. These kinds of evil acts against honest Americans will end by Abolishing the IRS; however, the accountability for the harm they caused will continue on until it is paid in full.

There were so many people in Colorado who had been damaged, the following year the Colorado Legislature unanimously passed their 1998 Resolution to Abolish the IRS. Yet – people in Colorado are still being damaged by criminal acts of IRS officials; therefore, **We the People in Colorado are asking the legislature to enact into law their 1998 Resolution to Abolish the IRS**. Over the years, we have studied the constitutions and laws and found **IRS officials committing numerous non-disclosure frauds**. Many Supreme Court cases state clearly that **'income' is not wages** – yet, the American people and the people for whom they work have been *tricked, deceived and coerced under threat by IRS officials* into treating their wages as 'income'. Also, **there is no clear law which states that the people within the several states are 'subject' to the federal government or its taxing 'code'**. In fact we found that the *IRS 'code' installs 4 planks of the communist manifesto* – reason enough to abolish it!

It is time that we return to the real laws of this country and the U.S. constitution which states that the federal government's costs must be apportioned amongst the several states. Please do not present yet another *unconstitutional taxing system*. It will certainly be challenged in the courts and I doubt that many Americans will comply.



We the People in Colorado Declaration of Natural Rights Amendment 7 Notice and Demand

4 July 2003

We the People.

People who have placed our signature(s) declare, Decree and Witness to each other people in the world, that:

us is, and all our posterity are, the sovereign people in the original Colorado Constitution, Article 2, Sec. 1-3 states, in part: "The people of this state have the sole and entire right of governing themselves, as a free, sovereign independent state,..."

Original Constitution, Amendment 7 & CRS 2-4-211 Re: Common Law (Emphasis mine/ours)

I/We, nor our ancestors or posterity have ever knowingly or intentionally:

- 1. renounced our natural, sovereign and un-a-lien-able rights, endowed to us by our Creator - Nature's God.
- 2. entered any contract or agreed to be held as surety on any government bond or loan of any kind. Nor have any of our family or we authorized any government agent or agency to 'pledge' ourselves or our property as surety on any government bond or loan of any kind or by any name.
- 3. entered any contract with, consented to, franchised, granted special or exclusive privilege or immunity from the law to any individual; association, such as *members of a private, political club - Bar Association; or corporation, such as the U.S. government located in Washington, D.C.*
- 4. entered any contract with, consented to, franchised, granted special or exclusive privilege to any individual lawyer or attorney; association, such as *members the Bar Association, to represent We the People in Colorado in any court, anywhere, anytime except by mistake or duress, duress and coercion by members of that private club and/or their accommodating agents who are profiting from pirating we the people's county courts by bringing maritime law inland to deny we the people:*
- 5.) our natural God-given rights as secured by the Bill of Rights.
- 6.) equal justice in law

now prevents the state government, its agencies or agents from granting any corporation, association, or individual any special or exclusive privilege, immunity or franchise whatsoever. *Colorado Constitution, Article V, Sec. 25.*

now prevents the state government from making anything of silver and gold in payment of debts. See See CRS 11-61-101 Legal Tender.

always spell our names - which are our private, copy-righted property - in upper and lower case in accordance with grammar and never in all capital letters as that is an unlawful, criminal, fictional impersonation of our lawful selves created by government/attorneys to fiscally and otherwise trap us.

have discovered that from birth, both we, our ancestors and our posterity have been repeatedly tricked and deceived by signing or responding unto various attorney/government-created documents:

with a misnomer, i.e. name with a middle initial See *Black's Law Dictionary* which were not fully disclosed by the creators of those documents which were designed to usurp and/or destroy our natural rights and sovereignty and, by deceit, trickery and unlawful conversion, in an attempt to change We the American People from sovereigns who have natural rights into legal fictions termed 'persons' and 'subjects' which are 'granted' only 'civil privileges' by a fiction called government or the imposter corporation.

'subject'" which is in direct conflict of law: Colorado State Constitution, Article II, Sec. 1-3, which names we the people as the sovereigns, and as such, are American Nationals.

- 8. I/We, our ancestors and our posterity are not now, never have been, nor ever will be legal fictions termed 'persons' or 'subjects' nor are we or our private property to be used as surety in any bonds or loans of any kind or by any name, i.e. Certificates of Participation, for which we have not knowingly, willingly or intentionally signed. By law, no other entity can obligate our bodies or our property as surety on any bond or loan, whatsoever, no matter what the 'loan' is deceitfully named, such as the C.O.P.s
- 9. I/We Declare and Decree that the only lawful reason for any government agency or agent to exist is to protect the natural rights, privacy and property of We the People. The agent of the several states, the U.S. government, and many other accommodating government agents and agencies have become a threat to our natural rights, our privacy and our property.
- 10. We come forth now asking the question: What hidden government and who are its agents which are misconstruing our original republican form of government as well as attempting to unlawfully convert our standing and character from Colorado state sovereign Americans into their 'subject/slaves' and for what foreign government?

I/We the People hereby Declare, Claim, Decree and Serve Lawful Notice to all entities anywhere and at all times that I/We, our ancestors and our posterity are natural-born sovereigns who possess un-a-lien-able rights from the beginning of Nature's Creation. I/We the People hereby Declare Independence from any government, government agency or agent that violates our natural, sovereign and un-a-lien-able rights and hereby Demand the abolition of all government or quasi-government agencies and agents or who/which violate our natural, sovereign, private and un-a-lien-able rights. We the People in Colorado will hold a/c count-able and liable, in both their personal and their professional capacity, all those who have violated or continue to violate and/or trespass upon our natural, sovereign rights as American Nationals.

I/We the People in Colorado who have placed our signature(s) below, declare, decree and witness to each other and to all people in the world that, by natural law declared by our American forefathers, and as secured in the original Constitution of 1787, Bill of Rights Amendment 7 of 1791 adopted by the sovereign states, united as America and the Colorado Constitution of 1868, Article II, Sec. 1-3, I/We and our posterity are American sovereigns living within the original boundaries of Colorado state Republic and are behold to no individual, association, or corporation for any unsigned-for debts whatsoever. That no debt can exist for which there is not a contract signed by both parties in which there was equal exchange of objects of real value.

I/We now demand that any man or woman, agent or agency now come forth to refute these facts and law, in writing, by their original signature and with lawful witnesses stating absolute Truth and producing documents we knowingly, willingly and intentionally signed which would refute these facts and law within 20 days of this date 4 July 2003 or these statements will forever establish our character and standing in law in any place, any court, any where, any time, past, present or future!!!

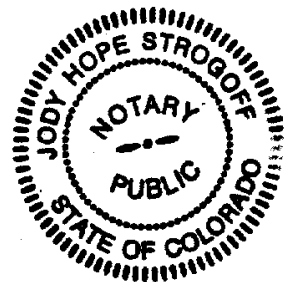
