Dear Senator Mack:

Please excuse this handwritten letter. I will have a new computer and printer on or about 31 July 2005. My data can be typewritten after that date.

Now that you no longer <sup>are</sup> an active Senator, I am delighted to learn that you are Chairing the President's Panel on Tax Reform. I consider the creation of a fair and almost painless tax system to be a long overdue obligation of the Government. I feel that it is my obligation as a citizen to do all possible to assist with such a creation.

Regarding tax reform, I first contacted Representative Billy Tauzin on 18 February 1999. On May 4, 1999, Representative Tauzin sent to me a copy of the National

Retail Sales Tax Act (NRST) of 1997 (H.R. 2001), reintroduced again on April 15, 1999 as H.R. 1467. Rep. Janzin also sent to me a 1999 updated information packet.

From Rep. Janzin's documents, I have composed a Bill, complete in Bill format and language, ready to present to Congress, such Bill I feel, is much improved over Rep. Janzin's Bill. My proposed Bill, for example, eliminates tax credits headaches and exempt organizations. I would like to reproduce and send a copy of my proposed Bill to you for presentation to your committee.

What is needed to supplement the Bill, are words explaining how the new tax organization should be structured, how it would operate, and include details on how to deal with tax cheaters, tax evaders, etc. The glory of my proposed Bill is that, automatically, the poor do not have to pay taxes on life-necessity items. Also, automatically, all others pay a FAIR tax according to the products and processes they procure. That supplement is in pencil/sink form now.

I would like to start typing the "How-to" supplement and send same to your Committee, but, unfortunately, that cannot happen until after July 31, 2005. The key to success in my Bill is instant directive and information data via computer. Update and other vital information can be changed real time to sellers and buyers. The system is simple and quick-responding to needs of the Government to raise or lower taxes.

My Bill provides fair distribution of the tax burden. It is fair to capital and labor. It eliminates VAT and AMT. It eliminates taxpayer income reporting. It reduces Government manpower size to run the system. It eliminates the taxpayer paper frustrations because of the tax pay-as-you-go feature. There are many, many more good features across many spectrums.

Any flat tax is NOT a flat tax; be it ten percent, 17 percent, or whatever amount. The frugal, less fortunate people get hit the same amount as the big spenders in a flat tax. Not a fair tax.

I was most impressed by the TV presentation of one of your Panel's meetings. Could you send me a list of all the people on the President's Advisory Panel on Tax Reform? On T.V., I saw and heard:
