In re: **3rd RESPONSE to Notices #CP-518, 541 &
Ltrs. #2269C, 2764C, 725(DO/CG), and 1862(SC)**

Dear Dennis L. Parizek & Other Service Representatives:

In response to the above-cited fusilade of Letters and Notices, the last of which was received on October 5, 2004, I continue to declare and maintain that the Paperwork Reduction Act as well as Title 26 of the U.S. Code do not require that I file— indeed, *prohibit* me from filing— an income tax return for 2000, 2001, 2002, 2003, and, thus far, 2004, for I *remain unemployed* since October 6, 1999, and have *never* been self-employed since then. Your persistent harassment of me to the contrary coupled with your consistent willful LIES to the effect that I have failed to perform the useless act of filing a Return for tax-year 2000 is becoming troublesome enough that it seems I am going to have to *sue* you and your Agency for injunctive relief and damages to cause this persecution to cease. Perhaps my newly reapportioned Congressman Henry Bonilla will be able to assist me as well. This abuse cannot be further tolerated!

Factual Background:

On July 8, 2002, I sent you back your “Information About Your Return” Form attached to a four-page Affidavit which recited the entirety of the law and circumstances regarding my Settlement Agreement with the federal government (NASA, my former employer) in a *dispositive* manner regarding the major amount in question. Moreover, I sent you a two-page Response in further explanation and as a “progress report” on August 13, 2002, and then **I completed, signed, and mailed in a 1040 for 2000** on September 11, 2002. YOU IN FACT *RECEIVED ALL THESE THINGS* and acknowledged such with your Letters 2269C and 2764C dated July 31, 2002, and September 16, 2002, respectively. Since your letters indicated *receiving* these Responses from me in this matter, and since that Affidavit is the *totality* of my substantive position, I continue to suggest you retrieve and (re)read them carefully. I very much resent your trying to mischaracterize my communications with your Office to achieve some sort of illicit tactical advantage, and your

outrageous pretense regarding what records you have in your possession can no longer be tolerated. I don't know whom you think you are dealing with or what your examining manual claims such phony techniques will likely produce, but I assure you that **YOU HAVE EVERYTHING FROM ME THAT YOU ARE ENTITLED TO UNDER LAW** and substantially more in addition thereto—furnished on *multiple* occasions! My tax liability was and remains **ZERO** to date.

Incredibly, and true-to-form for the IRS, you attempts to intimidate and **EXTORT** illicit funds from me continued by way of your scheduling my personal appearance at your local offices here on Callaghan Rd. by letter (#725[DO/CG]) for the morning of March 4, 2003, whereupon I personally and physically **SUPPLIED YOUR AGENT FELIX NUÑEZ (employee ID No. 74-00539) WITH YET ANOTHER COPY OF MY 1040** for tax-year 2000. Worse still, you continued to ignore even these duly submitted papers and last year threatened to subject me to so-called “backup withholding” (Notice #CP541 dated October 19, 2003) for failure **TO PAY** just any unspecified tribute—a truly vacuous threat insofar as I remain unemployed and have no meaningful assets you could attach. Your thuggish charade about not having responses from me or records of said responses is as *willfully false* as it is dishonest and cannot be maintained before a court or other neutral third party. The above-cited records of admission you have mailed me do not support your libelous allegations against me, and it is high time I end your illegal behavior and secure ultimate relief from your improper confiscatory practices.

Nor I do not accept the coincidental possibility that this matter has merely fallen between a multitude of cracks among hosts of incompetent IRS bureaucrats. No, this is **WILLFUL HARASSMENT** and smacks of the identical ordeal I was forced to endure back in 1995, which is why, within a month of this correspondence, I intend to serve you with a FOIA/PA Request to produce evidence of your *criminal conspiracy* against me; failure to respond will trigger a civil action from me within ten calendar days. It is becoming increasingly clear to me that you are **collaborating with other U.S. Agencies** in illicit, actionable *retaliation* for righteous and successful actions I undertook against the federal government and its corrupt practices during my employment with NASA—retaliatory harassment which has even reached the depths of dispatching armed **BATF** agents to my home in San Antonio to arrest me for suspicion of being the Washington Beltway Sniper! Enough is enough....
